

## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to Incometaxconnection.com, and Incometaxconnection.com and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Incometaxconnection.com include Incometaxconnection.com, AGInumber.com and taxquestions.org. ### **Collection of your Personal Information**

- Comply with an existing legal obligation; or
